

**Nailsea and District Croquet Club**  
**Minutes of Committee Meeting held on 23<sup>rd</sup> April 2019**

**1. Apologies - none.**

**2. Minutes of meeting held on 19<sup>th</sup> March 2019** - a hand written amendment was made to item **10.2 Tournaments**: now reads 'At present the Golf Croquet B class tournament is over subscribed.'

The minutes were then agreed and signed.

**3. Matters Arising**

**(a) Bid Requests (Item 11)** - Graham has now spoken to John Wallace regarding the extra work involved in hosting the tournaments. The committee agreed that a bid should be submitted for both events.

Graham has spoken to Kathy, and the bids have been prepared and submitted.

**(b) Handicaps (Item 14)** - A list has been placed in the clubhouse identifying individual handicaps (for those who have submitted their handicap cards).

**4. Treasurer's Report** – discussed and noted.

4.1 Electricity – following discussion with EDF, Mike has renegotiated the monthly payment.

4.2 Short Croquet was very successful and made a profit for the club.

4.3 Autumn reseeding - Mike will discuss with John Wallace the possible costs of this activity, which will take place over the winter months.

5.2 Three social events have been agreed for the summer, which will bring income into the club and possibly two new members.

The corporate booking on the 4<sup>th</sup> June clashes with matches and coaching sessions, so Brian will liaise with Kathy to ensure everything works well on the day.

5.3 New Toro – A problem has been highlighted with the use of the New Toro. Brian will discuss the issue with Geoff and John and report back at the next committee meeting.

5.4 Fire Extinguisher – this has just been replaced but unfortunately when the old Toro machine was taken the extinguisher went with it. Brian will ensure its return.

**6. Membership Report**

Club membership stands at 75 paid up members of which 10 are social members.

#### **7. Lawns Report:** discussed and noted.

A comprehensive report had been received from John who has regularly updated members during April re the condition of the lawns. It was identified that consideration needs to be given regarding the use of the lawns during the winter season. It was agreed to discuss 'winter use' at the August committee meeting.

#### **8. Website:** continues as work in progress.

As requested, Mike has looked at and identified information that could be removed from the site. The information on the levelling work has been removed and archived electronically. Old news items have also been removed. Discussion took place regarding what should be on the site and all agreed that in order for it to be helpful and user friendly, it had to be simple and kept up to date. A suggestion was made to just have the basics on it eliminating the need for constant updating. Mike will continue to review pages on the site that could potentially be removed.

Peter agreed to ask League captains to send reports to James to input onto the site.

Mike has provided the local newspaper with a report on the Short Croquet weekend.

#### **9. Safeguarding**

Linda has been in communication with Jean Hargreaves, and has sent the relevant link to her regarding information that should be on the CA Safeguarding website.

James to discuss with Jean Hargreaves if his DBS can be accepted; Peter Dyke's DBS is in date. Jean Hargreaves does not appear to have information on Erica's DBS status.

#### **10. Coaching**

During the month, emails and correspondence have been sent to members updating them of the coaching sessions that are now available and information is also available in the club house. Linda is taking AC coaching on alternate Tuesday mornings, David Hunt on Thursday mornings, Ryan alternate Friday evenings at 17.30 hrs and Kathy is running the course for beginners. This is over and above the individual coaching that has been taking place. Linda will send out a 'coaching update' near the end of the week and Peter will be starting junior coaching very soon.

The committee identified that there was a need to develop criteria for individuals who have completed the beginner's course and then indicate they wish to join the croquet club as a playing member. The club has responsibility under 'safeguarding' regarding vulnerable adults and children. Linda will liaise with Kathy.

## REPORTS

Treasurer's report for NDCC committee meeting 23<sup>rd</sup> April 2019

This report has been prepared on 18<sup>th</sup> April 2019.

Spreadsheet for the financial year attached. You can print the summary page if you wish by going to the High Level Actuals worksheet tab.

Balance at the bank less unpresented cheques is £12,987.51

The surplus for the year is £3,286.02. Without the £5,000 loan we would be £1713.98 in deficit. £4,701.02

The abrupt change from our last meeting is due to the purchase of the replacement Toro which cost £6,000 including VAT, which was the lower end of the budget range.

I have signed up to a new 2 year fixed price tariff with EDF which is less expensive than the previous one which expired on 31<sup>st</sup> March. I then fended off an attempt to increase the monthly direct debit from £49 to £80.

Competition entry fees for all through-the-season competitions have been received. In 2017, our last normal year, entry fees amounted to £427, but that includes the on-the-day competitions which have not yet happened.

Sales of tea, coffee and cakes at the Short Croquet Teams weekend netted a little less than £300. We will also receive the CA lawn hire rate (not sure if this is £50 or £60 per lawn day) for 11 lawn days, but we will not receive this until the end of the season.

Membership subscriptions are now in apart from the young juniors. Of the £10,090, £360 was for winter memberships.

The 100 club entries have responded well to Coral's encouragement with £636 received.

Income from here on will be mainly from refreshments, tournament catering and bridge. The major item of expenditure will be the insurance premium, about £1000.

## CA matters

- I have placed bids as per Committee instructions for the Selectors' Weekend in September 2021 and for the AC World Championship in 2022. I requested acknowledgement of the e-mail but have not so far received this. I will phone the CA Office before the 30 April deadline. I am not inspired to confidence by the fact that all those working in the CA Office have distinct emails but they can all read all of them. This, added to the fact that there are sometimes personnel changes, could lead to things being missed.
- We received 4 Nailsea entries for the GC All England so we have entered independently (Bristol also had 4 and this seemed the best way forward for all involved). We now have three Nailsea entries for the AC All England and Bristol have one entry so we may well put in a joint entry to the CA. I am currently in discussion with David Goacher and Ray Ransom about this.
- The fee for both the All England competitions is cited as £7 per person in the Fixtures Calendar but the CA entry form asks for £6 per person. I hope this will be clarified by the CA in due course.

## Lawn Maintenance Report - March 19

### 1. Lawns.

Coming up to the end of March the forecast for early April was cold and dry. This presented a dilemma in terms of the application of the Spring granular fertiliser as the grass obtains little benefit at low temperatures. After discussion with Duncan Hector I decided to apply the granular fertiliser, together with the first Revolution spray of the season on Sunday, March 31<sup>st</sup>. Four hours of irrigation was employed to water in both products. As luck would have it, the following Thursday/Friday heavy showers occurred and nearly an inch of rain fell in two days. This was highly convenient as the fertiliser granules were fully dissolved and the Revolution well watered into the ground. On the Friday afternoon there was surface water everywhere and the usual puddles in a few dips. However, by Saturday morning this water had drained away - unlike last year when it used to hang around for days at a time.

By the time of the SWF Short Croquet Teams event the lawns had responded well to the fertiliser, thus justifying the decision to apply it. The last cut with the old mower was made on Thursday April 11<sup>th</sup>. The new Toro was delivered on April 15<sup>th</sup> and training of all but one mower was provided by Geoff and Terry on April 16<sup>th</sup>. The first cut with the new Toro took place on April 18<sup>th</sup>. Despite the cutting height remaining at 8mm, the cut took considerable grass off - an indication that the grass growth is accelerating. Regular twice weekly mowing will now commence. Lawn speed was measured at 10.5 plummers in late afternoon. This is a pleasant speed for club play and suggests that the cutting height can stay at 8mm for a few further weeks. Warmer dry weather is being forecast for the rest of April and possibly into May and June. There is therefore no need to reduce cutting height at present.

Generally speaking the first few months of the year have been quite dry, with the exception of the first two weeks in March. Figure 1 shows the latest data. Note that from now on the lawns are likely to lose more water through evapo-transpiration than they gain through rainfall.

### 2. Winter play.

Although the grass is beginning to grow, some of the hoop approach areas remain threadbare and will need heavy overseeding this Autumn. Looking back over the winter months my main conclusions are:

- a. Keeping all the lawns open all winter makes essential repair and maintenance impossible. Some winter closures will therefore be needed in future years.
- b. The lawns were often used when it was either raining or the ground was really too soft to play. It is difficult to give precise instructions about when to play or not play. Partial lawn closures to rest the lawns are a simpler way of managing the situation.
- c. Consideration needs to be given to the possibility using small lawns rather than full size lawns during the winter as this relieves the main hoop approach areas of much wear and tear. Some other clubs do this regularly.
- d. The lawns sward is not yet mature. As the years progress the turf will gradually knit together and make the lawns more resilient. This process will be supported by

overseeding to improve sward density. The application of growth regulator during the summer months will also encourage root development and lateral tillering rather than vertical growth.

### 3. Autumn Programme 2019.

The next LAG meeting has been arranged for April 29<sup>th</sup>. The main items to be discussed are:

- a. Reduction in Annual Meadow Grass
- b. Over-seeding techniques and costs
- c. Top dressing to smooth out small dips - needs and costs.
- d. Lawn closure programme

Annual Meadow Grass (AMG) is an ongoing nuisance as it seeds all year around, is disease prone, not drought tolerant and also unsightly. All amenity lawns suffer from AMG and Nailsea is no different. East Dorset and Buddleigh both have plenty of AMG present in their lawns.

It is difficult to get rid of because of the seeding habits. There are three main chemical solutions:

1. *Euthofumesate*. This is a licensed product that can prevent the growth of AMG seedlings. It is not however licensed for amenity lawn use and cannot eliminate established plants.

2. *Growth Regulators*. In the USA a combination of two growth regulators Primo Maxx 2 and Trimmit effectively eliminate AMG. Primo Max 2 is licensed for use on amenity lawns in the UK but Trimmit is only licensed at low doses for certain crops in the UK. It cannot be used for amenity lawns. We use Primo Maxx 2 as a growth regulator to improve the sward but it may also slow down AMG seed production and reduce its rate of spread.

3. *Glyphosate*. This product kills everything including rye grass so it has been selectively applied to AMG clumps with a guard to prevent spread to the surrounding rye grass. I am in the process of modifying my own backpack sprayer so that a stronger glyphosate solution can be rapidly applied to AMG without harming the lawns. Duncan Hector uses glyphosate but immediately over-seeds the AMG and covers the seed with green waste. If this is done in the Autumn, then new rye grass fills in where the AMG had been previously and no holes appear in the lawn. The green waste method of sowing has proved to be very effective over the winter just gone. Many completely bare patches on the North boundary now have a quite acceptable grass covering so there is high confidence in this technique.

In the longer term, as the Mycorrhizal fungi build up in the soil and regular over-seeding is implemented the rye grass should dominate the AMG. However, rye grass does not spread quickly so it needs a helping hand at present. Note however, that total elimination of AMG is probably impossible as seed exists everywhere in the environment.
